### **Stallion Contract For Artificial Insemination**

I hereby confirm my reservation for the stallion services of the stallion \_\_\_\_\_  
Reg# \_\_\_\_\_ for the fee of \$ \_\_\_\_\_ in order to inseminate the Andalusian/Non-Andalusian mare  
\_\_\_\_\_ Reg# \_\_\_\_\_ for the breeding season February 1st through September  
30th, year 20 \_\_\_\_\_. I understand and accept the following terms. A current breeding soundness exam  
showing the Mare to be in sound breeding condition and free of infection are conditions of service.

1. A \$ \_\_\_\_\_ (10%) non-refundable booking fee must return with this contract.
2. Mare owner is responsible for payment of all veterinarian charges, lab fees, container rental fees, courier service, and shipping expense, necessary to collect stallion and inseminate the mare.
3. When semen is being shipped, Rothrock Andalusians is not responsible for care of this semen from the time it leaves the ranch. Mare owner will take full responsibility from time of shipment and understands that stud fees are non-refundable.
4. If mare does not conceive by September 30th, she may return the following breeding season, unless other arrangements have been made and agreed to by both parties.
5. In the event that a live foal (one that stands and nurses for 24 hours) does not result, the Mare, or a suitable replacement Mare approved by stallion owner, may be returned for breeding during the same year as the foal was to be born, free of any additional stud fees. Proper written notification that Mare has slipped or produced a non-viable foal must be forwarded to Rothrock Andalusians within 1 week of slippage or non-viable birth, by a licensed veterinarian.
6. It is agreed as follows: A breeding fee of \$ \_\_\_\_\_ which includes the booking fee in section 1, must be paid and received before Mare is inseminated and/or semen is shipped.
7. Mare owner assumes the risk of illness, injury, or death of mare. Mare owner shall provide his/her own insurance for such risk.
8. In the event of death or incapacitation of the contracted stallion, another Rothrock stallion may be chosen by mare owner in replacement to fulfill this contract.
9. A breeder's certificate will be issued to the Mare owner after all fees and expenses have been paid in full and upon notification to Rothrock Andalusians of the birth of the foal.
10. Any questions arising under the terms of this contract shall be construed and enforced under the laws of the state of Illinois.
